CONDITIONS OF ENTRY

1. PLEASE ENCLOSE A LARGE (MINIMUM SIZE: 9" x 6") S.A.E. TO RECEIVE NOTIFICATION OF ACCEPTANCE AND PASSES - EXHIBITS WILL NOT BE ACCEPTED IF THIS IS NOT COMPLIED WITH.
2. PRIVATE VEHICLES ARE PROHIBITED FROM MOVING ON THE SHOW SITE BETWEEN 9:00AM AND 6:00PM UNLESS ACCOMPANIED BY A STEWARD.
3. Vehicle permits will only be issued on acceptance to the Rally - 1 car and caravan and 2 people per exhibit.
4. **PLEASE NOTE: ENTRY PASSES MUST BE DISPLAYED ON ALL VEHICLES AND CARAVANS OTHERWISE THE FULL ADMISSION PRICE WILL BE CHARGED. ALL CARAVANS/CAMPERS MUST HAVE FIRE FIGHTING EQUIPMENT.**
5. All exhibitors, except static displays, will be expected to take part in their section's vehicle parade if one takes place.
6. All exhibitors must book in with their section secretaries on both days before 10 a.m.
